INGESTION:

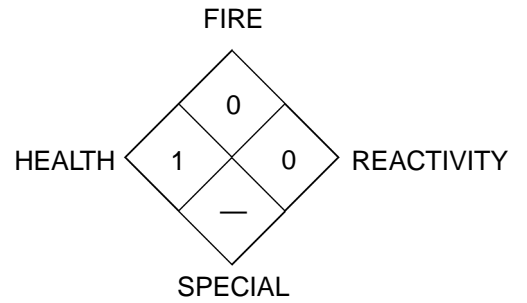
